The Eurasanté Bio-Incubator relies on **two bodies to select new projects:** the Scientific and Ethics Committee [SEC], the Approval Committee [AC]. The SEC's opinion is only advisory for applications to join the acceleration programme.

THE BIO-INCUBATOR'S SCIENTIFIC AND ETHICS COMMITTEE

includes experts in the various healthcare sectors from public and private research and Industry.

THE APPROVAL COMMITTEE

decides which projects are accepted for the programme concerned from those submitted to it.

This committee is permanently made up of representatives of the Bio-Incubator's financial backers as well as Eurasanté's partners from corporate, economic, and scientific backgrounds.
